2. Subsequently, based on his subject field of study (Mechanical Engineering) his candidature was referred on 28/01/2014 to M/s Tamilnadu State Transport Corpn, Tirunelveli, by this office, for consideration in the selection of Graduate Apprentices at their organization.
3. Vide letter No.14988/P4/TNSTC/TNV/2013 dated 27.03.2015 from GM, Tamilnadu State Transport Corpn.(TNM) Ltd. (copy enclosed) it is inferred that Sri Bharanikumar M, was called for attending interview on 22nd Feb.2014, vide call letter No.14988/P4/TNSTC/TNV/2013 dated 4.2.2014, by Tamilnadu State Transport Copn., Tirunelveli, and he has not attended the interview on the said date.
