- **I. Minimum Educational Qualifications:** B.Com (Any stream) First Class Graduation (3-year duration) awarded by any recognized Indian University in the respective field with not less than 60% marks. (**Full Time Course only**)
- II. Procedure for Submission of Applications: Eligible Candidates (B.Com any Stream) are requested to download the excel sheet from the below link and fill the excel sheet and forward to boatebquery@boat-srp.com for consideration, since there is no provision for enrolment of Non Engineering students in the portal.

- III. Age: Age limit will be followed as per Apprenticeship Rules.
- **IV. Reservation of Vacancies:** All provisions and guidelines with respect to Reservation for SC/ST OBC/PWD will be followed as per Apprentices Act. Candidates from SC/ST/OBC/PWD categories are to submit original caste certificate as per Government's standard format. Candidates from OBC category should bring OBC certificate as per the Govt. prescribed format from the certificate issuing authority or Tahsildar.

- **V. Duration of Training:**_The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act 1973.
- **VI. Previous Training/Experience:** Candidates who have already undergone or are currently undergoing apprenticeship under Apprentices (Amendment) Act 1973, and/or having one year or more experience are not eligible to apply.
- **VII. Selection Procedure:** The Selection list would be prepared according to categories General / SC / ST / OBC on the basis of marks obtained by the candidates.

VIII: Travel Expenses: No TA/DA will be paid for attending certificate verification.

IX: Boarding / Lodging: No boarding or lodging expenses are admissible.
